Bombardier Flexjet Fractional Ownership. Full Delight.

Indy racing legends, PGA pros, film directors and Fortune 500 CEOs would all seem to be prime candidates for business jet ownership. They are — with a twist. 
The fractional concept is simple. Fractional business jet ownership allows one to purchase a percentage share of the equity in one or more types of aircraft. Bombardier Flexjet, a leading fractional ownership program, offers ownership shares of as little as one-sixteenth to as much as one-half of a new Bombardier-built business jet.

This is not a charter or a time-sharing arrangement, however. Flexjet owners make an initial capital investment to lease or purchase their aircraft and then pay a set monthly management fee that covers costs for the hangar, insurance, and the crew. Operating expenses such as fuel, maintenance, standard catering, and standard airport landing fees are covered in an hourly rate per actual flying time used. It makes for simple accounting for business deductions. In fact, when you add up these costs and look at them in terms of the after-tax cost per month, it is surprisingly affordable. You can own your own Learjet starting at just \$7,700 a month.

Because the aircraft in which you own a share is part of a large fleet and identical to others of the same type, a jet is always available. Depending on your ownership level, you can arrange a flight with as little as four hours notice. Also, Flexjet aircraft are never chartered to non-owners. Would you consider allowing a third party to rent out your car for weekend excursions and keep the proceeds?

Headquartered in Dallas, Texas, Flexjet began operations in 1995 with 22 owners and 15 aircraft. Seven years later, the company has grown to nearly 700 owners and more than 100 aircraft. Not surprising given that Flexjet owners can avoid the hassle of the larger commercial airports and arrive at any one of the 5,000 less-congested, smaller airports in the United States not long before their scheduled departure time — a time that they set for themselves.

Unlike competing fractional programs, Bombardier Flexjet is backed by the full resources of an aircraft manufacturer.

The team is available round the clock, 365 days a year, to anticipate every need, to handle every detail. In addition, Flexjet has the only standardized catering program in the fractional industry, created by one of the foremost experts in the science of high-altitude dining.
